It's Almost Too Good To Be True

“Things aren't looking good dear.” Mary told her daughter. “The facility raised the rates again. They want three-thousand dollars a month now. On top of this, the doctor tells me I need to be on a different heart medicine, but it costs \$75 dollars a month. I wish I could get different insurance to help pay for all of this, but everything is so expensive. Your father and I thought we had saved enough for these years, but we never expected everything to cost so much. His end-of-life care really ate into our savings. I have less than ten-thousand dollars in the bank now, but that's too much to be qualified for any government programs. At this rate, I just don't know how I can afford to keep living.”

Many seniors today face the difficult and frustrating reality of trying to pay for basic needs, such as food, shelter, medicine, and health care, on a quickly dwindling budget. Forced to choose between food and medicine, they are often denied for government programs Medicaid because they have too much in income or assets.

In this situation, many people feel the pressure to “spend down” and get rid of money, assets, or other disqualifying items, so that they can get the help they desperately need. But seniors, and/or disabled individuals, do not need to do this. Instead, you can keep your money and assets, and qualify for Medicaid, or other government programs, with a Pooled Special Needs Trust.

A Pooled Special Needs Trust shelters income / assets, essentially removing the disqualifying asset(s) / income from the equation, allowing seniors and/or disabled individuals to qualify for much needed government assistance.

IS IT LEGAL?

Yes, a Pooled Special Needs Trust is a completely legal way to shelter income / assets from government programs.

According to the Qualified Medicaid Trust Guidelines and Forms for Florida (DCF A-22), “the qualified Medicaid pooled trust for disabled individuals is a legal instrument which meets criteria in 42 U.S.C. §1396 (p)

(p)(4)(c) and which allows disabled individuals to place assets and / or income into a trust to qualify for Medicaid assistance.”

The trust should also meet the following Federal codes, and Social Security and state Medicaid guidelines, to ensure that it simultaneously qualifies for many different government programs.

- Federal Code -42 USC Sec. 13996p (d) (4):(C)
- Social Security – SI 01120.203 Exceptions to Counting Trusts Established on or After 1/1/00
- Qualified Medicaid Trust Guidelines and Forms Florida DCF A-22 (refer to manual policy in chapter 1640)

HOW DOES IT WORK?

The Pooled Special Needs Trust must first have an established account, a process which is fast and easy. Once the trust is established, anything that is over income or asset goes into the trust. Anything under income or asset goes into your bank account. If at any time your personal bank account gets close to being over the limit of the government program you're on, simply transfer the difference to the trust.

Additionally, you can use the funds in your trust to pay for bills, such as your mortgage, rent, or facility payment, utilities, and other bills as needed.

WHAT ARE THE BENEFITS?

Depending on what type of setting you live in, the Pooled Special Needs Trust can help you in a variety of ways.

and requested by the account holder. Trust administration fees are deducted directly from your account. Fees vary by trust provider.
